I guess that comes from being around for awhile! Well anyway let's have the very best 2024 possible. That includes the music business and everything going on with each of us personally as well.

If you are a regular reader of the newsletter, you know that we had a number of successful negotiations during this past year. This year brings us more opportunity for gains in yet more of our CBA's including the PSO, Pittsburgh Musical Theater, and River City Brass once again.

We are having a great year with MPTF having played over 50 projects so far in MPTF's fiscal year which began last May and ends at the end of this coming April. It's really gratifying to be able to put so many musicians to work through the Music Performance Trust Fund. So far we have seen over \$45,000.00 in scale wages paid to musicians representing all styles of music from classical to pop and jazz. We utilized all of our \$29,000.00 allocated to our Local and are still doing more projects using other Local's allocations. When other Locals do not use all their allocated dol-

PSO-JOHN WILLIAMS

On a Tuesday night this past December, the Pittsburgh Symphony Orchestra performed a benefit concert for the orchestra and engaged composer and conductor **John Williams** to conduct the orchestra performing some of his classic compositions and featuring violinist **Anne-Sophie Mutter**. Williams has adapted some of his film music especially for Anne-Sophie turning some of these themes into concertos for her. Mutter has performed with the PSO many times here and abroad when this great orchestra is on tour. Cellist **Pablo Ferrandez**, also performed along with Mutter and the orchestra. This was music from "The adventures of Tin Tin" which was an animated feature film. Also on the program was a performance of Beethoven's "Triple Concerto for Violin, Cello, and Piano" which also included pianist **Yefim Bronfman**. Among the pieces featuring Anne-Sophie were Rey's Theme from "Star Wars: The Force Awakens" and Hedwig's Theme from "Harry Potter and the Philosopher's Stone". There was much more of William's music featuring the orchestra. If you haven't been to Heinz Hall in a while to hear this world class orchestra, you truly owe it to your self to get there as many times as you are able. Here is one of the world's best at your doorstep! As for John Williams, he has composed the music and served as music

director for more than one hundred films. Williams has received five Academy Awards and fifty-one Oscar nominations for his work. Just incredible. Together, the orchestra and Williams create an electric atmosphere not to be experiences all that often. I had the privilege of playing an after concert reception with **Rick Purcell** for John Williams at Heinz Hall many years ago. Hearing the orchestra perform all the great movie themes he has composed is an experience not to be forgotten. Hope you were in the house for the latest John Williams appearance in the 'Burg. If not, please do yourself a favor and attend any PSO performance at "the Hall". You will be glad that you did! Hope to see you there soon! Heinz Hall is a short walk from just about anywhere in town. BTW, we have a negotiation coming up between the PMU and PSO management later this year as this is the final year of the current contract. It is our sincere hope to get the kind of agreement that the members of the orchestra are so richly deserving of. This is most important for the musicians, the Local, and the entire Pittsburgh region. It is imperative that we keep these outstanding musicians here in the 'Burg. Every effort WILL be made to do just that! Stay tuned.

BARBER OF SEVILLE

I took in a performance of the Pittsburgh Opera's production of Barber of Seville this past October at the Benedum Center for the Performing Arts. Right up front let me say how excellent the orchestra sounded. Not surprising but worth a mention here. For those not familiar with "Barber", let me enlighten you just a bit. First, the opera was written by Gioachino Rossini and premiered on February 20, 1816 at the Teatro Argentina, in Rome. The opera recounts the events of the first of three plays by French playwright Pierre Beaumarchais that revolve around a character named Figaro, the barber in question. As you may know, Mozart wrote an earlier opera, The Marriage of Figaro in 1786. This opera is based on the second part of the Beaumarchais trilogy. Rossini, by the way, is said to have completed an average of two operas per year for 19 years, and in some years writing as many as four. Musicologists believe that the music for *Il barbiere di Siviglia* was written in just under three weeks. Pretty astounding! According to all accounts, the premiere of the opera at the Teatro Argentina was a complete disaster with the audience hissing and jeering throughout with several on stage incidents as well. I should interject here that I witnessed no such outbursts at the Benedum. The opera is in the style of a comic opera or opera buffo composed in two acts. It is considered to be one of the greatest masterpieces of comedy within music, and has been described as the opera buffa of all "opera Buffe". After two hundred years, it still remains a most popular work. I won't attempt here to give a synopsis of any kind as the story line is, at least for me, way too complicated to put into words. If you enjoy opera and have not seen this one performed, I strongly suggest that you make a point of attending a performance of "Barber" at either a future performance here in Pittsburgh or

elsewhere. It was a most enjoyable evening out and, again, the orchestra was truly excellent, conducted by maestro Antony Walker. Hope to see you at a future Pittsburgh Opera production. A huge fan is Financial Advisory Committee member **Hal Weiss** who rarely misses a production of Pittsburgh Opera. I can honestly tell you that I have become quite a fan of opera since being elected to this office. I, like Hal, rarely miss a production. Really hope to see **you** at one soon!

QUESTIONS FROM MEMBERS

As you might expect, we are asked many questions here at the Local involving just about anything you can imagine. I've decided to publish some here in this newsletter in the hope that some questions that you may have are answered. Here are a few of them with appropriate answers.

Question: What's the best way to contact the office? I called but no one was there.

Answer: Often times our phones are busy with previous callers. You may leave a voice mail but I would strongly suggest an e-mail at president@afgmpittsburgh.com for George or mandy6454@hotmail.com for our office manager Miriam. You may also call my cell at 412-855-5137 or for Miriam you may dial 412-215-9545. **Miriam is the best contact for dues questions, address changes, and general information.** Miriam is kept quite busy with the items just mentioned and so much more. Question: Why are the dues being raised in 2024?

Answer: The simple answer is to enable the Local to continue to do business without unduly dipping into our cash reserves such as our Vanguard Fund. While we have found it necessary to do so over the past several years, we would

prefer to find other means of remaining financially stable. The only raise in dues over the past 21 years was the result of a \$10.00 tax placed on all members by the Federation well over 10 years ago which resulted in a \$10.00 increase for all members. The Local has not raised dues during that period of time other the aforementioned tax by the AFM.

Question: What's the best way to learn more about MPTF funding for gigs?

Answer: There is much info regarding MPTF in past newsletters. You may contact me (George) to get all the particulars on how to apply for MPTF funding.

Question: How many people work in the Local's headquarters?

Answer: There are two people employed by the Local on a full-time basis. One is the President-Secretary and the other is the Office Manager. We also have a Vice-President and five Directors or Board Members. The Officers and Directors make up what is known as the Executive Board which is the ruling body of the Local. I should point out that our vice-president and directors do not keep office hours at the Local, only Miriam and myself. At one time there were as many as 8 full-time employees at the Local including officers and also 7 Directors instead of the current 5 on the Board.

Question: I am nearing the age where I wish to begin taking my pension. How do I go about this?

Answer: The best and really only way do this is to either visit the AFM-EPF website at www.afm-epf.org or call the Fund at 1-800-833-8065. The Local is unable to answer any personal questions as to what your pension may look like or address any beneficiary issues. These can only be answered by the Fund and must be directed there.

Question: What duties does the President-Secretary perform?

Answer: This question pops up frequently and was last asked of me a matter of weeks ago. Here is the short answer. The President-Secretary is responsible for making sure that all ten collective bargaining agreements in our Local are negotiated and maintained. In addition, the President-Secretary is responsible for the QuickBooks accounting program, minus cutting checks done by Miriam, publishing the quarterly newsletter using Microsoft Publisher, and administering the Music Performance Trust Fund in our Local which is done on-line. Additionally create agendas for all monthly Executive Board and General Membership Meetings and preside over the meetings. Also deal with workplace grievances and any arbitrations that may arise. In a nutshell, the President-Secretary executes the previously mentioned duties and supervises the general business of the Local. In a future newsletter I will outline the duties of our

office manager **Miriam Lesikiewicz** which are many!!!

NORTHMONT UNITED PRESBYTERIAN CHURCH

Speaking of MPTF projects, there was one that took place on Sunday morning, November 5th at Northmont United Presbyterian Church on Perry Highway. The Academy Orchestra, contracted by **Warren Davidson**, performed the Faure' Requiem for a large group of parishioners there at the 10:00am service. Churches represent another venue other than senior centers, schools, and other types of community celebrations where MPTF gigs may occur. This project also included a rehearsal held the day prior. The payday included the \$105.00 for the rehearsal, \$120.00 for the performance, \$15.00 transportation for each day, and pension. The appropriate cartage was paid as well. Over \$270.00 per musician half of which was paid by a grant from MPTF. We are doing what we can to generate live music in the Pittsburgh area. BTW, the 13 piece Union chamber orchestra did a great job as evidenced by the enthusiastic response by many church goers following the service. WHEELING SYMPHONY ORCHESTRA

This past October, on a Thursday evening, I made the trip across I-70 to Wheeling West Virginia to catch the WSO in concert featuring the **Violins of Hope**. Now, I have to admit that I really didn't know what the "Violins of Hope" really were. I'm sorry to say that I had no idea what this represented. Well, the Violins of Hope involves string instruments played by Jewish concentration camp prisoners during the Holocaust which, of course, was one of the darkest of all times in our world history. Each surviving instrument has a unique and inspiring story that connects both young and old to the history of the Holocaust in a deeply emotional, personal, and relatable way. I believe there were a dozen or so of these instruments played during the concert that night in Wheeling by members of the orchestra. Very emotional and inspiring to be sure. As to the concert, the orchestra sounded excellent as usual while performing a variety of relevant music. Clarinetist **Roi Mezare**, whose family was directly impacted by the Holocaust, performed a concerto by Paul Ben-Haim that featured himself and the string section of the orchestra. Roi is a member here in our Local as well as Local 42, Wheeling and sounded marvelous. It was my first time hearing Roi perform a solo piece and was truly worth waiting for. Also on the concert was a work by Walter

Bricht featuring pianist Dominic Cheli. Bricht, a Jew, was so popular in Germany during the first half of the 20th century that in 1938 he was offered honorary Aryan status by none other than Adolf Hitler himself should he pledge allegiance to the Third Reich. Bricht declined and fled to the United States settling in West Virginia where he taught at a conservatory in Charleston. This concerto was discovered in Vienna, Austria by Michael Ellis Ingram who guest conducted the performance. Also on the program was Felix Mendelssohn's Third Symphony. The music director is John Devlin and **Robin Driscoll** serves as personnel manager of the WVO.

THE FLYING DUTCHMAN

I made another trip to the Benedum Center for the Performing Arts in November to take in a performance of Wagner's The Flying Dutchman. This is an Opera where I would challenge anyone to try and catch up on any sleep! Well, I did a little research on this opera as I like to do, especially if I'm not very or in some cases at all familiar with the work. This opera of course was written by Richard Wagner who due to an extravagant lifestyle and his actress wife's retirement found himself bankrupt. While Wagner was writing Rienzi he and his wife devised a plan to escape to Paris and put that opera on stage at the Paris Opera. However, their passports were seized by the authorities at the request of their many creditors. This required them to make a dangerous and illegal crossing over the Prussian border. They boarded a ship whose captain agreed to take them without passports. After a dangerously stormy trip they ended up in Paris where Wagner was unable to get work as a conductor and the Paris Opera did not want to produce Rienzi. It was then that Wagner hit on the idea to write a one act opera based on the theme of the Flying Dutchman. A result of the stormy sailing trip? To make a long story short, the opera was completed in 1841. The score was intended to be played continuously in a single act but Wagner later divided the piece into a three act work which is how it is performed today most everywhere. As always, the Pittsburgh Opera Orchestra did itself proud with a stirring performance of what many consider to be one of the most difficult of operas to play. Even Al was duly impressed! As always, I would encourage you to take in a performance of Pittsburgh Opera. It is truly an experience that you will remember. I have friends who will attend a PSO concert, a CLO show or a Pittsburgh Ballet Theater production but will not attend an opera because they do not like operatic singing. Well, I would say that it may be an acquired taste for many but if you don't go you will never know if you like it or not. Believe me, taking in a live performance of anything is so much more exciting than popping a CD into a player and hearing music that way. Just try the opera once, give it a fair chance and see if you don't return to the Benedum again for yet another production. I do not go there due to any real or imagined obligation on my part to do so. I go because I do take great pleasure in being

there. You just might do the same.

UNION MEMBERSHIP

I do want to address the issue of Union membership in this journal. If you were to look at any of our Collective Bargaining Agreements, under UNION SECURITY you will see the following language:

"As a condition of employment, all musicians covered by this agreement who are members of the Union on the execution date of this Agreement shall maintain their membership in the Union as a condition of employment, and those who are not members shall, no later than thirty-one (31) days following the date of execution of this Agreement, become a member of the Union and maintain such membership in good standing. All musicians hired after the execution of this Agreement shall, no later than the thirty-first (31st) day after the commencement of their employment, become members of the Union and maintain such membership as a condition of employment."

Now the Union referred to here is none other than Local 60-471. Here is the language:

"This agreement is made and entered into the ___ day of _____ by and between Acme Opera, Inc (hereinafter referred to as "Opera" and the Pittsburgh Musicians' Union, Local 60-471, AFM (hereinafter referred to as "Union"). There can be no mistake about what Union signifies. It is clearly Local 60-471, Pittsburgh Musicians' Union. We have countless members who are contractually required to belong to multiple Locals. My wife, for example, belongs to Local 60-471, Pittsburgh, PA, Local 136, Charleston, WV, Local 142, Wheeling, WV, and Local 269, Harrisburg, PA. There are many such members in our Local and in most every Local throughout the Federation. It's simply the cost of doing business. There are also rebates for any AFM member who belongs to 3 or more Locals. You need simply apply to the AFM to receive them. I will add that this Local will enforce the language requiring Union membership, or better put, membership in Local 60-471 as a condition of employment. The Union is here for the protection of every member musician and we take that very seriously. I do hope this sets the record straight for some who feel that they are "above the law" so to speak. Please know that this Local is here for the betterment of all of our musicians and will continue to negotiate and fight on behalf of all our members.

STERLING AND STRINGS

The trio known as Sterling and Strings performed a concert of Christmas music at W & J during the lunch hour recently. The dining area was quite full of faculty members who were most appreciative of the holiday music. The trio consists of **Melissa Lessure**, flute, **Rebecca Rothermel**, viola, and **Susanna Reilly**, cello. The performance highlighted Christmas music through the ages beginning with some little known very early short pieces and ending with the most popular White Christmas. There was even a Ha-
